Visa Requirements for the Great Socialist People's Libyan Arab Jamahiriya

An entry visa shall be issued to a foreign passport holder, provided that the passport meets the following requirements:

- ***The passport must be translated into Arabic by a licensed legal translation office.***
- ***The translation must be attached to one of the actual passport pages, either as a written or stamped article or as an affixed sticker***
- ***The translation must bear the licensed legal Translation office's stamp across both the translation and the passport page.***
- ***This regulation shall be retroactive, applying even to those passport holders who have already been approved for a single entry or multiple entry visa prior to their arrival in Libya.***

The above mentioned regulations shall take effect immediately

****All diplomats and VIP guests shall be exempt from the above mentioned regulations****
